Date and Remarks	Orders of the Tribunal
Order No. 3 16th July, 2014	<p>Vide order dtd. 09.07.2014 in Misc. Application No. 330/2014, the State Government was directed to make available a copy of the "Master Plan for Mandideep" on the next date of posting. This direction was issued as it was found that the Master Plan made available and taken on record relates to Raisen District and not particularly to Mandideep.</p> <p>The Learned Counsel appearing for the State has submitted earlier and it was recorded in the order dtd. 28.05.2014 that it is not the case that there is no Master Plan in force and in fact a Master Plan has been in force since 2005 and all developments and Real Estate work is being carried in accordance with the land use as provided under the Master Plan of 2005.</p> <p><u>Misc. Application No. 345/2014</u></p> <p>Today the Learned Counsel appearing for the Respondent No. 9 filed a copy of the draft Master Plan for Mandideep which is proposed to be in force till 2031 along with Misc. Application No. 345/2014. Even in this application also it is not stated whether there was any</p>

Master Plan in existence for Mandideep from 2005 as represented earlier and recorded in the previous order. The draft Master Plan produced along with Misc. Application No. 345/2014 is taken on record.

The Learned Counsel appearing for the State Government seeks time to file an appropriate affidavit on the ambiguity as to whether there was any Master Plan in existence for Mandideep from 2005 as recorded earlier or not.

Misc. Application No. 329/2014

In Misc. Application No. 329/2014 the applicant sought directions not to proceed with the process of making DPR for sewage treatment plant, till the dispute with regard to the feasibility of the proposed landfill is settled. Though, the Learned Counsel appearing for the Respondent No. 7 Mandideep Municipality on 09.07.2014 submitted that the DPR was prepared and proposal for Environmental Clearance has already been moved before the concerned authority, today the Learned Counsel submitted that it was filed before the authority only on 14.07.2014. Though, a reply was filed today to the Misc. Application No. 329/2014 by the Respondent No. 7, therein, it is not specifically stated that the DPR was prepared and submitted to the concerned authority. In such circumstances, the Respondent No. 7 is directed to file, an appropriate affidavit clarifying the position, before the next date of hearing.
